2. Are there any liquidated damages on this project, if so how much?

3. What is the budget for this project?

The County has established a budget of \$1,600,000 for the project.

4. What is the completion date for this project.

The County has not established a project duration or completion date for the project. Per Section 00 01 20, Proposers are required to provide a proposed schedule to be considered as part of the evaluation.
